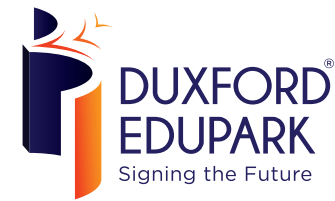

PEDAGOGY

The pedagogy at DIBS is focused on the principles of experiential, action-oriented and applied learning. It integrates the most advanced teaching-learning process with case studies, simulations, business games, role plays, structured and unstructured group work, field visits etc.

The learners get to interact with thought leaders and industry experts at regular intervals. They will be motivated to integrate the concepts learned through the courses with their prior work experiences and current business scenarios.

ASSESSMENT

The assessment at DIBS has two components. Impact Assessment and Learning Outcome Assessment.

Under Impact Assessment, the impact of the programme on each learner is assessed. Learning Outcome Assessment is carried out by using standard application-oriented tests, case solution exercises, live projects and assignments.

ADMISSION

The admission process is based on a well-defined set of eligibility criteria that considers the candidate's previous academic performance, extra-curricular activities and individual personality.

Step 1: Application

Register by filling up the online application form which is available on the DIBS website.

Step 3: Documents Verification

The selected students are required to submit the following documents for verification:

Certificates & Mark Sheets of Class 10th and Class 12th/HSC

ID Proof (Aadhaar/Election ID/Passport)

Bachelor's Degree Transcript & Mark Sheets

Score Card (LMAT/ MAT/ XAT/ CMAT/ GMAT/CUCAT)

Documents of previous academic performance and extracurricular activities.

Step 2: Shortlisting

Identifying candidates who meet our eligibility criteria in a preliminary shortlisting.

Step 4: Selection Process

The shortlisted students are invited to campus for the DLAT Admission Test followed by a Group Discussion (GD), Just A Minute (JAM) and Personal Interview (PI) with Institute Faculty and External Industry Experts where a prospective candidate is assessed in terms of capability, general awareness and confidence.

Step 5: Admission Offer

The selected applicants will receive a provisional admission offer, to join the upcoming batch, within five working days after the selection process.

The whole process which includes DLAT will be conducted in different locations for the shortlisted candidates. To complete admission formalities, candidates must make the first instalment payment within 15 working days of receiving an offer.
